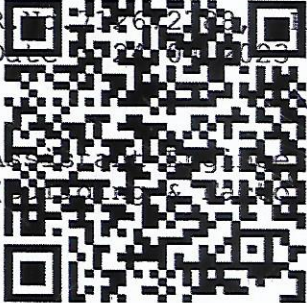



conditions and restrictions.

- (a) The requirements, conditions and restrictions already intimated vide this office letter's No.:786199935 dated 01.04.2023 .
 - (b) The measures provided for the prevention of the nuisance and hazard shall be used and kept in working order.
 - (c) The factory premises shall not be used for residential purpose.
 - (d) Smoking in the factory premises shall be strictly prohibited.
 - (e) No person under the age of 15 years shall be employed in the factory.
 - (f) No alteration shall be made in (i) the site of the factory (ii) the total area of the factory (iii) the mechanical power used (iv) the number of furnaces or forges employed (v) nature of the process carried on (vi) the permitted hours of working (vii) the number of employees (viii) no additional process shall be started without prior written permission of this office.
 - (g) No furnace, fire place, fuel or chimney shall be allowed in the premises unless specifically permitted by the Chief Inspector of Steam Boilers and Smoke Nuisances, Government of Maharashtra.
 - (h) The requirements, if any, of the Chief Inspector of Factories, Government of Maharashtra shall be carried out.
 - (i) The necessary licenses, under the provisions of section 394 of the B.M.C Act for the storage of articles or for carrying on the trade or operation shall be obtained.
 - (j) Any requirements or conditions, if prescribed from time to time, even after the issue of the written permission, shall have to be complied with.
- (2) This permission may at any time be suspended or revoked by the Municipal Commissioner of Greater Bombay if
- (a) It has been secured through misrepresentation or fraud.
 - (b) Any of its restrictions or conditions is infringed or evaded.
 - (c) The permit holder is convicted of an infringement of any of the provisions of this Act or of any rule or byelaws regulation, standing order in any matter to which this permit relates.
 - (d) The factory has stopped working for a continuous period exceeding one year.
 - (e) The factory is found to creating nuisance from noise, smoke, dust, fluff, effluvia odour, vibration or any other cause.
 - (f) The factory is found to be in any way dangerous to the public health and safety.
 - (g) The structures or part thereof in which the factory is housed is found to be ruinous, destroyed or pulled down.
- (3) When the permission is suspended or revoked or when the period for which the same is granted expires, the permit holder shall for the purpose of the said Act be deemed to be without a permission until the Municipal Commissioner's orders for suspending or revoking the permission are rescinded by him or until the permission is renewed as the case may be.
- (4) The permission shall be produced for inspection whenever requirement by the Municipal Commissioner for Greater Bombay or by any other officer imposed by him in this behalf.
- (5) This permission is not transferable.
